- 1. On the basis of the report of the inspection committee(Appointed by the "Affiliation and New Teaching Programme Committee" in exercise of its power vide section 39(c) of the Statute of AKU) which visited your institute on 21-08-2012 to verify the various infrastructural facilities provided for running 1(One)course was further examined by the "Board of Affiliation" (Constituted vide Section 23 of the AKU Act read with Section 19 of the AKU Statute) on dated 24.08.2012 and their recommendations were placed in the meeting of "The Court" held on 25.08.2012 for its perusal and approval. The "Court" resolved to give provisional affiliation to Maitreya College of Education & Management for one year for the session 2012-13.
- 2. Accordingly I am pleased to inform that Maitreya College of Education & Management has been granted provisional affiliation for one year from the session 2012-13 (01) (One Course) subject to the approval by the state government.

- ## 4. The fulfillment above provisional affiliation is subject to of all the observations/shortcomings/deficiencies pointed out by the inspection committee in its report dated 21-08-2012.
 - a. Sufficient number of equipments should be kept in the laboratories and it should be arranged properly.
 - b. Number of computers should be increased up to 25.
 - Hostel facility may be provided in due course of time.
 - 5. Endowment amount must be deposited in the form of bank draft drawn in a. favour of "Aryabhatta Knowledge University, Endowment Fund" within a week of the receipt of this letter.
 - b. Affiliation fees, if not yet deposited, must be deposited in the form of Bank draft drawn in favour of "Aryabhatta Knowledge University, Affiliation Fund" within a week of the receipt of this letter. In case of Non-Compliance of 5(a) and 5(b) no further processing of affiliation

will be done.

6. Since provisional affiliation given at first instance is valid for one year only from the date of issue of this letter, thereafter, three months before the closure of present academic year, the management of the college shall make an application in writing to the University, along with the compliance report about short comings mentioned earlier by the inspection team, for grant of continuance of provisional affiliation. AKU reserves the right of frequent inspection/inspections of the institution according to rules and regulations of the statute till permanent affiliation is granted.

Rules/Regulations regarding conduct of examination will be communicated later.
