- Jointly owned, exclusively licensed to the Institution.

#### **6. Term and Termination:**

- This MOU shall be effective as of the date first written above and shall remain in effect for a period of **Five** years.
- Either party may terminate this MOU with **30** days prior written notice to the other party upon **material breach of the agreement**.

#### **7. Dispute Resolution:**

- Any disputes arising out of or relating to this MOU shall be resolved through **amicable negotiation, mediation, arbitration**.

#### **8. Governing Law:**

- This MOU shall be governed by and construed in accordance with the laws of **specify jurisdiction**.
- All parties to this MOU agree to comply with all relevant laws and regulations of the jurisdiction in which they are situated. Furthermore, any representatives shall adhere to all applicable laws and regulations in the jurisdiction of the host party. The parties may negotiate terms or accommodations for mutual convenience, provided they remain compliant with legal requirements.

#### **9. Entire Agreement:**

- This MOU constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.

#### **10. Amendments:**

- Any amendments to this MOU must be made in writing and signed by duly authorized representatives of both parties.

- If any provision of this MOU is held to be invalid or unenforceable, such provision shall be struck and the remaining provisions shall remain in full force and effect.
